**O R D E R**

The public authority is represented by Sri Girish Das, Deputy Director, Food and Civil Supplies and Consumer Affairs, Dibrugarh. The petitioner is one Shri Hari Prasad Gogoi, address- Kamalabari, (Baragadhoi), P.O- Duliajan, District- Dibrugarh, Pin- 786602, Cell No.- 9957899811. He filed an RTI petition dated 3-2-2014 before the PIO of Food and Civil Supplies and Consumer Affairs department , Dibrugarh, followed by first appeal petition dated 27-3-2014 and second appeal petition dated 5-9-2014.

Sri H. P. Gogoi present today has made a written submission dated 12-2-2016 , which is entered into the case records.

In his written submission he has stated that he has never filed any RTI petition as enclosed in this Commission's Notice dated 20-1-2016 which he received on 2-2-2016. Sri Hari Prasad Gogoi present today mentioned that there was another Hari Prasad Gogoi , with the same address, who has now shifted his residence to some other place. So it is likely that it is the other Hari Prasad Gogoi, with a new address which is not known to this Commission. However, his mobile No. is available with this Commission.

The Deputy Director, Food and Civil Supplies and Consumer Affairs who is present today stated that the first appellate authority had already heard and passed an order on 29<sup>th</sup> April, 2014, wherein it is recorded that the applicant agreed with the decision of the hearing.

This Commission, therefore, directs the Deputy Director, Food and Civil Supplies and Consumer Affairs Department to contact the RTI applicant Sri Gogoi, Cell No. 9957899819 and advise the applicant to collect the required information from the concerned GPSS within 30 days from the date of receipt of this order, if he is still interested in obtaining the information by paying the required cost.

This Commission's registry will also ascertain the present address of the applicant Sri Hari Prasad Gogoi by contacting him in his cell no and send a copy of this order.

With the above order, the second appeal petition dated 5-9-2014 is disposed of.
