## ORDER

The complainant Sri Deba Prasanna Borah is absent without information. The Public Authority of SSA is represented by (1) Sri K. K. Kalita, SPIO, (2) Sri P. K. Chakraborty, ASPIO, SSA, Assam and (3) Md. Mir Abdul Latif, Translator, SSA, Assam.

The complaint petition dated 6-3-2014 is taken up for consideration ex-parte in the absence of the petitioner and in view of the large number of pending cases.

The SPIO of SSA has made a written submission dated 4<sup>th</sup> February, 2016 stating that the information sought for by the petitioner / complainant vide his RTI petition dated 26-7-2013 was already furnished vide letter No. SSA/RTI/BDB/342/13/5343 (A) dated 18<sup>th</sup> October, 2013, although in his complaint petition dated 6-3-2014 the complainant has stated that he had not received any information from the public authority.

The SPIO of SSA has submitted before this Commission a copy of the above mentioned letter addressed to the petitioner Sri Deba Prasanna Borah. It is seen from the RTI petition dated 26-7-2013 that the petitioner did not indicate his Postal Index No.

From perusal of the reply given by the SPIO of SSA to the petitioner, as mentioned above, it is seen that there were some shortcomings. This Commission, therefore, directs the SPIO of SSA to furnish a clear reply to (a) question No.-1, i.e., the number of Contractual teachers that were in position and performing their duties in LP and UP Schools of Assam during the period from 1-4-2013 to 15-7-2013, (b) question No. 3 – whether the salaries of L.P and UP school contractual teachers are drawn from the Treasuries and if so the amount drawn during the above mentioned period and (c) - transfer the RTI application in respect of question No-4 to the TET Empowered Committee, in whose custody this information will be available, as stated by the SPIO of SSA.

The above information be sent to the petitioner / complainant by Registered A/D post within 15 days from the date of receipt of this order.
