The Public Authority is represented by Md. Omar Khayyam, SPIO, Office of the C.E.O., Barpeta Zilla Parishad along with Md. Afsar Ali, Office Assistant.

The Complainant absent without any information.

The Complainant had submitted his Complaint dated 14.08.2015 stating that the information furnished by the SPIO in compliance with the Commission's order dated 08.05.2015 did not match the Commission's order. The Complainant has however, not specified as to how the information furnished to him did not meet the Commission's order fully.

In view of his absence in today's hearing, further information on the matter could not be ascertained by the Commission.

Heard the SPIO. It has been submitted that the information required to be submitted in compliance with the Commission's order has indeed been furnished to the Complainant through a letter dated 01.07.2015. The SPIO has submitted a copy of the forwarding letter and its enclosures. Photocopy of postal receipt is also submitted as an evidence of the said letter having been posted by registered post to the Complainant. It is further submitted that the records relating to point no. 5 of his original Application dated 04.03.2013 was voluminous and therefore, the Complainant had been requested to inspect the said records on a specific date and time but that the Complainant did not respond.

In view of the facts that the SPIO has indeed supplied the copies of documents specified by the Commission and gave an opportunity to the Complainant to inspect and take notes of the relevant records he had sought for in accordance with the aforementioned order of the Commission, it is seen that the SPIO has complied with the orders of the Commission.

With this, the Complaint case is hereby disposed of and closed.
