**O R D E R**  
07.03.2016

Neither party present. A Written Statement dated 05.03.2016 has been received from the First Appellate Authority (FAA)/PD, DRDA, Dhubri. No W/S received from the SPIO and the Appellant.

Perused the W/S. It is seen that through his order dated 18.09.2012, FAA had directed the SPIO to provide the information in 7 days' time and cautioned him to be more diligent in furnishing information under the RTI Act, 2005. Perused also the copy of the letter dated 03.10.2012, attached with the W/S where with the SPIO/E.O.(P), Fekamari Development Block had supplied information to the Appellant. Seen that copy of the letter contains an acknowledgment of receipt of the information by the Appellant with his signature dated 01.11.2012.

In his Second Appeal dated 21.12.2012, the Appellant has acknowledged receipt of the said letter but has submitted that part of the information supplied to him was 'misleading'. However, the Appellant has not enclosed a copy of the reply given by the SPIO. In the absence of the Appellant in today's hearing and any specific detail information/evidence to establish his view about the information supplied to him being misleading, the Commission is not in a position to take a view on this matter.

In view of this, the Second Appeal Petition is hereby disposed of.
