**O R D E R**

The petitioner Sri Dulal Bora as well as the public authority to be represented by the SPIO of the office of Commissioner of Police, Guwahati both are absent.

In view of large number of cases pending before this Commission, the second appeal petition dated 6-6-2013 is taken up for consideration ex-parte in the absence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 18-2-2013 before the Additional S.P (Headquarter), Guwahati City, seeking information on all the registered cases from 1<sup>st</sup> July, 2009 to 30<sup>th</sup> June, 2011 at Noonmati Police Station with all details , such as : name of complainant, name of accused , Section and seizure list etc.

It is also seen that in response to his RTI petition dated 18-2-2013, the Addl. S.P vide his letter dated 21-3-2013 furnished information in respect of Noonmati Police case No. 135/2010 which was received by the petitioner under his signature on 23-2-2015. There is, however, no mention of information already received by the petitioner in his first appeal petition dated 6-4-2013 nor in his second appeal petition dated 6-6-2013.

This Commission observes that furnishing of detailed information of police cases registered in Noonmati Police Station over a period of 2 years, with all details will be a laborious and time consuming process..

If the petitioner is still interested in getting the entire information or part thereof he may approach the Officer-in-Charge, Noonmati Police Station. This Commission directs the Officer-in-Charge, Noonmati Police Station to allow the petitioner to take notes of the required information and photo copies thereof, free of cost up to 25 copies and thereafter on payment of Rs. 2/- for every additional copy within 15 days from the date of receipt of this order.
