## ORDER

The public authority is represented by (1) Smti Mayuri Chetia, SPIO and Joint Secretary, Revenue and Disaster Management Department (2) Sri Sanjeeb Kr. Das and (3) Sri Khagen Sarmah, Sr. Administrative Assistant. The petitioner Sri Dulal Bora is present.

The second appeal petition dated 28-6-2013 is taken up for hearing in presence of both the parties.

The SPIO and Joint Secretary, Revenue and Disaster Management Department has submitted a written statement dated 2-3-2016 stating that the then SPIO of the Department informed the petitioner vide letter dated 16<sup>th</sup> May, 2013 that the information sought for vide his RTI application dated 12-4-2013 is not available in the Department. The petitioner was advised to submit separate petitions before the Deputy Commissioners of Kamrup (Metro), Barpeta, Kokrajhar and Bongaigaon districts.

The Commissioner & Secretary, Govt. of Assam and the first Appellate Authority of Revenue and Disaster Management Department has submitted a separate written statement stating that the first appeal petition of Sri Dulal Bora was heard by his predecessor Sri H. N. Borah and it was disposed of by his order dated 29<sup>th</sup> July, 2013.

In his order the FAA mentioned that he was satisfied that action already taken by the Deputy Secretary and SPIO of R&D M Department advising the RTI petitioner Sri Dulal Bora to submit separate RTI petitions before the concerned Deputy Commissioners.

In view of the above, this Commission sees no further course of action on the RTI petition dated 28-6-2013 and hence it is disposed of.
