O R D E R

The petitioner Sri Dulal Bora is absent. The public authority is represented by Sri Niren Sarmah, MVI and SPIO of the office of the District Transport Officer, Kamrup (Metro).

In view of the large number of cases pending before this Commission, the second appeal petition dated 3-8-2013 is taken up for consideration, on merit, ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that the petitioner Sri Dulal Bora filed his RTI petition before the DTO, Kamrup (Metro) seeking information on detailed particulars of the Owner of vehicle registration No. AS-01-AK-2226. He also wanted information on the type of vehicle, its colour, and if it is a Govt. vehicle, then detailed information thereon.

The SPIO of the office of the DTO, Kamrup (Metro) submitted photo copies of their letter No. DDK/RL/RTI/2013/959 dated 4-4-2013, addressed to the petitioner Sri Dulal Bora furnishing him the required information. But in his first and 2nd appeal petitions dated 9-5-2013 and 3-8-2013 respectively the petitioner has stated non-receipt of the information as grounds for his appeal, which is contrary to the DTO's forwarding letter dated 4-4-2013 mentioned above.

This Commission, therefore, directs the SPIO of the office of the DTO, Kamrup (Metro) to send another copy of the information along with a copy of the forwarding letter dated 4-4-2013 within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 3-8-2013 is disposed of.
