**O R D E R**

The petitioner Smti Oshima Choudhury is absent without information. The public authority is represented by Sri Sujit Kr. Deb, ASI of Police, RTI cell of the office of Commissioner of Police.

He has presented before this Commission today a written submission dated 24-2-2016 of Sri Debraj Upadhaya, Deputy Commissioner of Police (Administration) and SPIO in the office of Commissioner of Police, Guwahati. The SPIO has submitted in his written submission that the required information was sent to the petitioner vide their office Memo No. ECP/RTI/286-13/2015/1141 dated 13-11-2015, which was sent by Speed Post. But the same was returned by the Post Office on the ground that the applicant could not be traced out in the new address given by her, i.e, flat No. 309, DDA, MIG Flats, Pink Apartment, Sector-18 'B', Dwarka, New Delhi-110 075.

It is seen from the case records that in her prayer dated 4-1-2016 before this Commission the petitioner wrote her address PIN as 110 078 instead of 110 075. This Commission, therefore, directs the Commissioner of Police, Guwahati to send the required information to the petitioner, once again in the new address given by her at PIN No. 110 078 in place of 110 075, all other details of the address remaining the same.

With the above order, the petitioner's prayer dated 19-8-2013 and subsequent prayers dated 18-12-2013 and 4-1-2016 are disposed of and the matter is closed.
