**O R D E R**

The petitioner Sri Dulal Bora is absent without information. The public authority to be represented by the SPIO of the office of Commissioner, Taxes , Assam is also absent

However, from perusal of the case records it is seen that the petitioner filed an RTI petition dated 22-3-2013 before the Commissioner of Taxes, Govt. of Assam, seeking information on collection of taxes from different sources with district-wise break-up for the period from 1<sup>st</sup> January, 2009 to 28<sup>th</sup> February, 2013,

With this second appeal petition dated 20-6-2013 the petitioner himself has enclosed a letter dated 6<sup>th</sup> April, 2013 addressed to Sri Dulal Bora, the petitioner himself from Sri B.B. Hagzer, Joint Commissioner of Taxes, Assam , furnishing the sought for information and there is also endorsement of receipt by the petitioner on 12-4-2013.

Therefore, it seems that the statement that the petitioner did not get any reply from the Commissioner, Taxes, as mentioned in his first appeal petition dated 4-5-2013 is not correct. The second appeal petition mentions that the petitioner is not satisfied with the reply received. But he has not enclosed a copy of the reply received by him and which part of the reply he is not satisfied with.

It , therefore, appears that the first appeal petition dated 4-5-2013 and the second appeal petition dated 20-6-2013 were filed by the petitioner through oversight

Hence the second appeal petition dated 20-6-2013 is dismissed.
