**O R D E R**

The petitioner Smti Indrani Baruah is absent without information. The public authority is represented by Sri Pradip Baruah, Headmaster of Dhakhin Ghilamara High School, Lakhimpur, P.O- North Lakhimpur.

The second appeal petition dated 6-1-2014 is taken up for hearing ex-parte in the absnce of the petitioner.

From perusal of the case records it is seen that the petitioner has already received the information relating to the period from 2000 to 2001. Vide letter dated 20-10-2013 the Headmaster of Dakhin Ghilamara High School informed the petitioner Smti Indrani Borah that the records of annual requirement and adhoc F.C for the period from 1996-1999 is not available. The present Headmaster Sri Pradip Baruah was not given those documents when he took over charge as full-fledged Head Master from December, 2012. Before that date from the year 2000 he was working as In-charge Headmaster on adhoc basis. The school was provincialized with effect from 1-1-2013 and before that got adhoc recognition for class 6-10 with effect from 1-1-1994.

The petitioner in her second appeal petition has stated that since the school was provincialized only on 1-1-2013 on the basis of informations furnished by the School to the Govt., therefore, the plea of non-availability of records is not convincing. Moreover, the information sought for by the petitioner is very simple, ie., annual requirement and adhoc F.C received by the school during the years 1996-1999.

This Commission, therefore, directs the Headmaster of Dakhim Ghilamara High Schopol to furnish those 8 figures i.e., annual requirement and adhoc F.C received by registered post during the years 1996, 1997 , 1998 and 1999 to the petitioner within 30 days from the date of receipt of this order.

With the above order, the second appeal petition dated 6-1-2014 is disposed of.
