ORDER

The petitioner/ complainant Sri B. C. Dori is present. The public authority Sri Prafulla Kr. Deori of Deori Autonomous Council, Narayanpur, Lakhimpur is present.

The Principal Secretary, Deori Autonomous Council has sent a written submission dated 10-2-2016 which is entered into the case records.

The complaint petition dated 12-11-2015 alleging non-compliance of the Commission's order dated 2-6-2015 is taken up for consideration in presence of both the parties.

Though the Complainant stated that after this Commission's order dated 2-6-2015 he had not received any invitation from the Deori Autonomous Council for inspection of the documents as ordered by this Commission, the Principal Secretary, Deori Autonomous Council Sri P. K. Deori stated that the petitioner did not approach him, nor did he come to his office for inspection of documents after this Commission's order dated 2-6-2015. The Principal Secretary, Deori Autonomous Council submitted a copy of their letter dated 19-9-2015 with which he enclosed a copy of his communication dated 18-9-2015. In his communication the Principal Secretary, Deori Autonomous Council informed the petitioner that the information sought for by him has been compiled. Detailed information like beneficiary list etc. are voluminous and therefore, it will take considerable time to prepare the same. The petitioner was requested to inspect those documents, if he desires to do so. When this Commission asked the petitioner if he has anything to say on the contents of the letter dated 18-9-2015 from the Principal Secretary, Deori Autonomous Council, he submitted in writing that he will be satisfied, if the information mentioned therein is made available to him. The Principal Secretary, Deori Autonomous Council also stated that the contents mentioned in the above cited letter is available and kept ready with him. It, therefore, appears that the complaint petition dated 12-11-2015 arose mainly due to communication gap between the petitioner and the public authority.

The Commission, therefore, directs the petitioner to visit the office of the Principal Secretary, Deori Autonomous Council within 15 days from the date of this order and inspect the necessary documents and collect the documents required by him, as already ordered by this Commission in its order dated 2-6-2015. The Principal Secretary, Deori Autonomous Council is also directed to facilitate inspection of documents by the petitioner and furnishing of the required documents to him, as ordered earlier dated 2-6-2015 within 15 days from the date of this order.

With the above order, the complaint petition dated 12-11-2015 is disposed of.
