O R D E R

The petitioner/ appellant Dr. Sushmita Choudhury is absent without information. The public authority is represented by Smti Jyotsna Medhi Patgiri , Addl Deputy Commissioner and PIO of Deputy Commissioner, Kamrup (Metro).

The second appeal petition dated 26-8-2013 is taken up for hearing ex-parte in the absence of the appellant.

From perusal of the case records, it is seen that the appellant filed her RTI petition dated 28th May, 2013 seeking information on whether a marriage was registered between one Surai Singha Choudhury, son of Sri Surya Kanta Singha Choudhury and Smti Sushmita Choudhury daughter of Dr. Dipul Choudhury. Her RTI petition was followed by first appeal petition dated 8-7-2013 before the first appellate authority which was heard and disposed of on 10-9-2013 with a direction to the Sub-Registrar of Kamrup (Metro) to furnish the information to the appellant within one month.

From the written submission dated 8-2-2016 filed by the SPIO and its enclosures, it is seen that the Sr. Sub-Registrar, Kamrup (Metro) informed the petitioner vide letter dated 4-11-2013 that no such marriage was registered as per his office records.

It is also noted that the second appeal petition is dated 26-8-2013, i.e., prior to the Sr. Sub- Registrar's letter dated 4-11-2013 furnishing the information to the petitioner.

In view of the above, the second appeal petition dated 26-8-2013 is disposed of.
