**O R D E R**

Neither party present. No Written Statement has been received.

However, in view of large number of cases pending for quite some time, the Commission has decided to take up the matter for consideration on merit.

From the perusal of the case records, it appears that the Appellant, Md. Jamiruddin Ahmed had filed the RTI Petition dated 02.03.2013 before the B.D.O., Hajo Development Block cum Circle Officer, Hajo.

The First Appeal dated 05.04.2013 was filed before the D.C., Kamrup (R) who had fixed 22.04.2013 at 3.00 PM for hearing of the Appeal. It is seen that the SPIO and Executive Engineer, Kamrup Zilla Parishad vide letter no. KZP(G)15/2008/556 dated 22.04.2013 furnished part of the information to the Appellant.

The Appellant filed the Second Appeal dated 04.05.2013 before the Commission stating that he was not furnished the complete information on the ground that documents were not available in the office of the SPIO.

In the absence of the Appellant in today's hearing and any written communication from him, the Commission could not determine as to whether he has received the remaining information he had sought for in the meantime.

There is no evidence of disposal of the First Appeal by the First Appellate Authority.

Therefore, the First Appeal Petition dated 05.04.2013 is remanded to the First Appellate Authority *i.e.* D.C., Kamrup (R) for disposal, with a speaking order, within a period of 21 days of receipt of this order.

The Petitioner will be at liberty to move this Commission with Second Appeal or Complaint Petition, as the case may be, if he is aggrieved by the decision of the First Appellate Authority because of non disposal of the First Appeal Petition by the First Appellate Authority.
