The petitioner Shri Harinarayan Pathak is present.

From perusal of the case records it is seen that on receipt of his RTI petition dtd 18.8.13 sent vide forwarding letter dtd 3.10.13, the DTO and Secretary, RTA, Kamrup (M) vide his letter dtd 9.10.13 forwarded information in respect of all the three points mentioned by the petitioner in his RTI petition dtd 18.8.13. The petitioner's Second Appeal petition dtd 19.11.13 is based on the ground that documents furnished to him are incomplete. But he did not enclose copies of the documents received by him for verification of his ground of appeal.

The Public Authority i.e. DTO & Secretary, RTA, Kamrup (M) sent a written submission dtd 29.2.16 praying for refixation of date of hearing as he had to attend another meeting with Addl. Chief Secretary, Transport Department. The petitioner/appellant also prayed for another date of hearing as he could not come prepared with the relevant papers as he had to attend to another matter in the office of the Deputy Commissioner, Kamrup (M). It appears that both the Public Authority and the appellant give higher priority to their other engagements rather than to appear before this Commission on date fixed.

In view of the large number of pending cases, this Commission will not allow wastage of its valuable time by the public authorities and the appellants. This Commission, therefore, directs the Appellant to personally contact the office of the DTO & Secretary RTA, Kamrup (M), Betkuchi, Guwahati-34 within 15 days from the date of receipt of this order. The DTO and Secretary, RTA is directed to furnish remaining information, if any, to the appellant.

With the above order, the Second Appeal petition is disposed of.
