O R D E R

The petitioner Sri Dulal Bora is absent. The public authority is represented by (1) Sri Moni Baruah, DIG (H.Q) of Prisons, Guwahati and (2) Sri Narayan Kalita, Jr. Assistant.

In view of large number of cases pending before this Commission, the second appeal petition dated 25-9-2013 is taken up for consideration, on merit, ex-parte in the absence of the petitioner.

From perusal of the case records, it is seen that the petitioner Sri Dulal Bora vide his RTI petition dated 2-7-2013 filed before the Inspector General of Prisons, Assam , seeking information about the repair/ renovation/ beautification and other developmental works done during the tenure of the then Inspector General of Prisons.

The public authority has submitted a written statement dated 9th March, 2016 stating that the petitioner's RTI petition of Sri Dulal Bora was received in their office on 9-7-2013 and the information was furnished to the petitioner vide letter No. PRI.62/2013/88 dated 26-7-2013 stating clearly therein that all such works were executed through the PWD after observing due formalities. The Office of I. G Prisons is not concerned with selection of contractors. Two statements showing the list of works done during the period 2011-12 and 2012-13 were also enclosed along with copies of sanctioning letters.

This communication dated 26th July, 2013 from the office of I.G, Prisons was received by the petitioner Sri Dulal Bora on 29-7-2013 under his signature.

Subsequently, the petitioner filed his first appeal petition dated 23-8-2013 before the I.G, Prisons and second appeal petition dated 25-9-2013 before this Commission. The grounds for appeal for both the petitions was that he was not satisfied with the information furnished. But he has not pointed out and explained which part of the information received by him under his own signature, he is not satisfied with. Without this, this Commission is not in a position to verify the veracity of the grounds for his appeal.

This Commission could not proceed any further due to the absence of the petitioner , nor he has prayed for extension of time.

In view of the above, the second appeal petition dated 25-9-2013 is disposed of.
