O R D E R

The petitioner Sri Pradip Kr. Sarmah is present. The public authority is represented by (1) Sri Babulal Sarmah, Director, Secondary Education, (2) Sri Abdur Razzaque, Inspector of Schools, Jorhat (3) Dr. Bhupen Talukdar, SPIO and Joint Director, Directorate of Secondary Education, Assam and (4) Sri Anjan Dutta, Sr. Assistant, Office of the Inspector of Schools, Jorhat.

The petition dated 1-10-2011 submitted by the petitioner Sri P. K. Sarmah, complaining of non receipt of the required information in compliance with this Commission's earlier order dated 18-6-2015 is taken up for hearing in presence of both the parties.

The appellant submitted that he has received copy of the original appointment letter relating to the appointment of Mrs. Deepanjali Sarmah. He has also received copy of order dated 20-3-2010 granting maternity leave to Smti Deepanjali Sarmah, and also copy of sanctioning letter dated 20-3-2010 granting earned leave to Smti Deepanjali Sarmah with effect from 20-5-2000 to 26-1-2001.

His complaint is that he has not received the remaining information, i.e., (1) copy of Note Sheet of the office of Directorate of Secondary Education where the matter of appointment of Smti Madhuri Borthakur as Principal In-charge of Malowali Higher Secondary School, Jorhat was processed. The Director of Secondary Education, Govt. of Assam has filed a written submission dated 15-3-2016 along with which he has enclosed the photo copies of the relevant note sheets of the file in which the matter of appointment of Mrs. Madhuri Borthakur as Principal In-charge of Malowali Higher Secondary School, Jorhat was processed. He has explained the delay in furnishing the information stating the ground that as it had to be searched out of huge volume of records.

On direction from this Commission, the Director of Secondary Education, Assam handed over 4 pages of the relevant note sheets to the petitioner in presence of this Commission. The petitioner also gave a written statement to that effect.

With the above, the Commission is satisfied that the petitioner has received all the information as sought for, and his complaint petition dated 1-10-2015 is, therefore, disposed of.
