**O R D E R**

The Principal, Deshabandhu Bidyapith H.S. School, Hojai is present. He has submitted a Written Statement dated 06.04.2016 and also a Written Statement 06.04.2016 from the Inspector of Schools, Nagaon.

Appellant absent without information.

The abovementioned Written Statements are taken into record. Through the W/S, the Inspector of Schools, Nagaon has submitted that he was unable to trace the records relating to the RTI Application and has instructed the Principal of the aforementioned School to provide the information as sought for by the Appellant.

Perused the W/S of the Principal. It has been submitted that the information had been forwarded by him to the Inspector of Schools, Nagaon 'through proper channel' on 19.09.2013 and that as no further correspondence had been received from the Petitioner, it was presumed that he had received the information. It has been added that the same information can now be provided to the Appellant again.

In view of the facts brought out above, the Commission hereby orders that the SPIO/Principal, Deshabandhu Bidyapith H.S. School, Hojai shall furnish the information sought for by the Applicant by post/special messenger under intimation to the Inspector of Schools, Nagaon within a period of 10 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
