## <u>O R D E R</u> 07.04.2016

The Public Authority is represented by DEEO, Nagaon along with an Assistant in his office, a representative from BEEO, Kathiatoli and Head Teacher, Patidoiya L.P. School. The DEEO has submitted a Written Statement dated 06.04.2016 which is taken on record.

Perused the aforementioned W/S. It has been submitted that the RTI Application dated 20.06.2013 had been transferred by DEEO, Nagaon to BEEO, Kathiatoli and the BEEO in turn had instructed the Head Teacher of the concerned school namely, Patidaiya L.P. School through a letter dated 01.11.2013 to submit the information. It has also been submitted that on receipt of the information/documents from the Head Teacher, BEEO's office had telephonically requested the Applicant to collect the information personally. However, the Applicant did not comply with the request and therefore, the information could not be provided. It has been added that the information is available and can be provided to the Applicant now. Under the circumstances it has been prayed that no penalty be imposed under the RTI Act, 2005 on account of delay in furnishing the information.

In view of the facts brought out above, the Commission hereby orders that the information as sought for by the Appellant shall now be provided by BEEO, Kathiatoli to the Applicant/Appellant by registered post, free of cost, within a period of 10 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
