**O R D E R**

The petitioner Shri Dulal Bora is absent without information. The Public Authority is represented by Dr. Bhupen Talukdar, Joint Director & SPIO of the Directorate of Secondary Education, Assam. In absence of the petitioner the Second Appeal petition dtd 17.12.13 is taken up for hearing ex-parte.

From perusal of the case records it is seen that the petitioner Shri Dulal Bora filed an RTI petition dtd 24.7.13 before the Director of Secondary Education, Assam. After not getting any response to the RTI application he filed First Appeal petition dtd 30.8.13 followed by Second Appeal petition dtd 17.12.13 before this Commission.

The Joint Director & SPIO has made a written submission dtd 7.4.16 stating that the information sought for by the petitioner Shri Dulal Bora was already furnished to him vide letter dtd 3.8.13. The First Appeal petition dtd 30.8.13 was also replied to by the SPIO vide his letter dtd 18<sup>th</sup> September, 2013. The SPIO has enclosed copies of these communications with his written submission dtd 7.4.16.

In view of the above the petitioner's Second Appeal petition dtd 17.12.13 is found to be without any merit. In his Second appeal petition the petitioner mentioned that he was yet to receive the sought for information. If he has actually not received the communications from the SPIO as referred above, the petitioner may contact Jt. Director and & SPIO in the Directorate of Secondary Education within 15 days from the date of receipt of this order and obtain the copies of information already sent to him.

With the above order, the Second Appeal petition dtd 17.12.13 is disposed of.
