<u>O R D E R</u> 20.04.2016

Both parties are absent. No written statement received.

In view of the large number of cases pending before this Commission, the Complaint petition dated 11.11.2014 is taken up for consideration on merit, based on record.

On perusal of the case records, it appears that Md. Jakir Hussain Barbhuiya had filed an RTI petition before the Anganwadi Workers, Anganwadi Centre No. 188, Rangauti, Hailakandi on 03.05.2014 seeking for information on the anganwadi centre as stated therein.

The petitioner filed the First Appeal before the CDPO, Hailakandi on 19.06.2014 stating that the information sought for was not furnished to him. On 21.08.2014, the petitioner filed a complaint against the CDPO, Hailakandi before the District Social Welfare Officer (DSWO), Hailakandi for non receipt of the documents. The DSWO, Hailakandi on 05.09.2014 transferred the application under section 6 (3) of the RTI Act, 2005 to the CDPO, Hailakandi ICDS Project to furnish the information sought for directly to the petitioner. The petitioner filed a complaint against the CDPO, Hailakandi before the Commission on 11.11.2014.

In the absence of the petitioner in today's hearing and no written communication from him, the Commission could not determine whether he had received the information he had sought for subsequent to the filing of the complaint petition dated 11.11.2014.

The Commission hereby directs that the SPIO, of CDPO, Hailakandi ICDS Project to furnish the information as sought for by the petitioner within a period of 10 days from the date of receipt of this order, if not furnished in the meantime.

With the above direction, the Complaint Petition is disposed of.
