<u>O R D E R</u> 12.04.2016

The Appellant is present with two assistants. The Appellant has also submitted a letter dated 10.04.2016 which is taken on record.

The SPIO has sent an apology dated 08.04.2016 stating that he is preoccupied with election duty until 12.04.2016. However, as the Appellant is present and he has expressed his difficulty in attending to hearings, the Commission decides to go ahead with the hearing *ex parte* SPIO.

Perused the aforementioned letter of the Appellant. It has been submitted that he was yet to receive the information he had sought for. Deposing before the Commission, the Appellant stated that he has not received any communication from the SPIO in any manner.

Perused the case records. In his letter dated 05.04.2016, the SPIO has submitted that the RTI Application had been submitted during his predecessor's incumbency but he has not indicated what actions he has taken or planned to take to ascertain the status of furnishing the information sought for and for making a Written Submission before the Commission. It is also seen that there is no evidence of the Chief Engineer, PWD (Building) Guwahati as First Appellate Authority having disposed of the First Appeal dated 01.07.2014 submitted before him by the Appellant. The Appellant has stated that he has not received any notice for hearing or any order from the said authority.

In view of the facts brought out above, the Commission hereby orders as follows:-

- i) The SPIO, office of the Assistant Engineer, PWD (Building), Darrang shall furnish the information sought for by the Appellant/Applicant, free of cost, within a period of 15 days of receipt of this order; and
- ii) The Chief Engineer, PWD (Building), Chandmari, Guwahati as First Appellate Authority shall consider and dispose of, with a speaking order, the First Appeal dated 01.07.2014 which was submitted to him by the Appellant/Applicant, within a period of 21 days of receipt of this order.

Send a copy each of the RTI Application and the said First Appeal to the SPIO, office of the Chief Engineer, PWD (Building), Guwahati, Assam.

With this, the Second Appeal case is disposed of.
