**O R D E R**

The Public Authority is represented by Smti. Salma Ahmed Hussain, Director/SPIO, AMDB, Assam along with her assistants.

The Appellant present.

The Appellant had submitted the Second Appeal dated 19.01.2015 on the ground that he had not received the information he had sought for from the SPIO through his RTI Application dated 27.10.2014. Deposing before the Commission, the Appellant submitted that he is yet to receive the information he had sought for.

The Director/SPIO, AMDB, Assam submitted a Written Statement dated 02.04.2016 stating that the RTI Applicant had already been supplied with the same information in response to the RTI Application dated 22.06.2012 which he had made along with three other persons. A photocopy of the acknowledgement of receipt of the information by one of the group members, who had been duly authorized by them including the present Appellant is enclosed with the W/S as an evidence.

Heard the Director/SPIO, AMDB, Assam, she explained the factual position with reference to the said RTI Application dated 22.06.2012 and the present Application stating that the information sought for through the two Applications were one and the same.

The Appellant submitted that he had not received the copy of the information from the person he had authorized.

In view of the facts brought out above, the Commission hereby orders that a copy each of the information/documents furnished earlier as mentioned above shall be provided to the Applicant/Appellant on payment of the cost of photocopying by him for the reason that a set of the information/documents sought for had already been furnished. The information/documents shall be provided, within a period of 7 days of receipt of this order.

With this, the Second Appeal case is disposed of.
