O R D E R

The petitioner Sri Dulal Bora as well as the public authority to be represented by the SPIO of Social Welfare Department both are absent without any information. However, the SPIO has sent a written submission dated 18th April, 2016 stating that the first appeal petition dated 30-8-2013 was heard by the First Appellate Authority on 19th December, 2013 in presence of the petitioner and the First Appellate Authority's order mentions that the petitioner's RTI petition dated 24-7-2013 was transferred to the Director of Social Welfare Department, Govt. of Assam and to the Deputy Commissioner, Nagaon under Section 6(3) of the RTI Act, 2005 vide Social Welfare Department's letter No. 638/2013/4 dated 6-9-2013. Copy of the order of the First Appellate Authority was endorsed to the petitioner Sri Dulal Bora also.

The petitioner's second appeal petition was dated 26-11-2013 , i.e, before the First Appellate Authority's order dated 19th December, 2013.

From the available case records and in the absence of the petitioner at the time of today's hearing it could not be made out whether the Deputy Commissioner , Nagaon and Director, Social Welfare have in the meanwhile furnished the sought for information to the petitioner

Under the above facts and circumstances this Commission directs the Director, Social Welfare Department, Govt. of Assam to furnish the sought for information to the petitioner, if they have not already done so, within 15 days from the date of receipt of this order.

Enclose a copy of the RTI petition and the second appeal petition along with this order to Director, Social Welfare and Deputy Commissioner, Nagaon

With the above order the second appeal petition dated 26-11-2013 is disposed of.
