**O R D E R**

The petitioner Sri B. Bezbaruah is again absent without any information. The public authority is represented by Sri Sarbeswar Doley, Deputy Registrar, Kamrup and Sri Daman Teron, Extra Writer of the office of the Senior Sub-Registrar, Guwahati.

The SPIO of the Office of Deputy Commissioner, Kamrup (Metro) has sent a written communication dated 20-11-2016 praying for re-fixing the date of hearing due to her pre-occupation with election duty. The SPIO did not mention what election duty kept her busy in the interim period after the polling was over on 11<sup>th</sup> April, 2016 and counting of votes on 19<sup>th</sup> May, 2016..

In view of the long pendency of this case and the large number of pending cases before this Commission, it is decided to take up the second appeal petition dated 22-11-2012 for further consideration, on merit, in pursuance of this Commission's earlier orders dated 25-2-2016 and 21-3-2016, in the absence of the petitioner and the SPIO of the office of the Deputy Commissioner, Kamrup (Metro), ex-parte.

The Deputy Registrar, Kamrup (Metro) , Guwahati has made a written submission dated 20-4-2016 stating that only one sale deed, bearing No. 253/02 was registered by Panikhaiti Sub-Registry office on 4-10-2012 and that no other sale deed bearing the same No. on the same date was registered by Panikhaiti Sub-Registry. Copy of this written submission has also been endorsed to Sri P.Bezbaruah, Amolapatty, B.R. Path, Dibrugarh, Assam.

This written submission clearly explains the information sought for by the petitioner vide his RTI petition dated 25-5-2012. However, as a measure of abundant precaution, this Commission directs the Deputy Registrar of the office of Registrar, Kamrup (Metro), Guwahati to send one more copy of his written submission dated 20-4-2016 to Sri P. Bezbaruah by Registered A/D post, so as to facilitate closure of this RTI case.

With the above order, the second appeal petition dated 22-11-2012 is disposed of
