**O R D E R**

The petitioner Sri Dulal Bora is absent without information. The public authority is represented by (1) Sri Ikramul Hussain, ACS, Joint Secretary, & SPIO of Personnel Department, Dispur, Guwahati-6 accompanied by (2) Sri N. Basanta, Jr. Administrative Assistant of Personnel Department. .

The petitioner Sri Dulal Bora is absent. In view of the large number of cases pending before this Commission, the second appeal petition dated 24-12-2013 filed by the applicant Sri Dulal Bora with reference to his RTI petition dated 10-8-2013 is taken up for consideration on merit, ex-parte in the absence of the applicant/ appellant.

The Secretary and First Appellate Authority of Personnel (A) has submitted a written submission dated 19<sup>th</sup> April, 2016 stating that the petitioner was furnished with the sought for information vide letter No. AAP.103/2013/9 dated 16-8-2013 in response to his RTI petition dated 10-8-2013, along with a copy of the information furnished to him.

The First Appellate Authority has also mentioned in the written statement that after furnishing the information and after receipt of the first appeal petition dated 2-9-2013, the First Appellate Authority fixed several dates for hearing of the first appeal petition and on every occasion the petitioner was absent. Finally the First Appellate Authority dismissed the 1<sup>st</sup> Appeal petition vide his order dated 11-3-2014.

This Commission also observes that the information already furnished to the petitioner meets the requirement of his RTI petition dated 10-8-2013,

Under the above facts and circumstances of the case and in view of the absence of the petitioner/ appellant, his second appeal petition dated 24-12-2013 is dismissed.
