O R D E R

The petitioner Sri Mukut Mahanta is absent without information. The public authority is represented by Sri Dilip Teron, Deputy Secretary, Karbi Anglong Autonomous Council, Diphu. The complaint petition dated 16-12-2013 is taken up for hearing ex-parte in the absence of the complainant.

The Joint Secretary In-charge of RTI of the department of Revenue, Karbi Anglong Autonomous Council submitted a written statement dated 11-4-2016 stating that the information sought for by the petitioner vide his RTI application dated 5-7-2013 has been furnished to him vide letter dated 22-2-2016, By his RTI petition dated 5-7-2013 the petitioner wanted copy of the Bordoloi Commission Report concerning inclusion of the then Borpathar / Sorupathar Mouza areas with the then Map from the Golaghat, Jorhat and Sibsagar district. The PIO and ASO of Karbi Anglong Autonomous Council informed the petitioner that the Bordoloi Commission Report sought by the petitioner is not available with the Council.

This Commission observes that records/documents which are 20 years old or beyond do not come within the ambit of the RTI Act, 2005. The petitioner, however, is at liberty to pursue the matter with the Director of State Archives, Govt. of Assam, Dispur, Guwahati-6. This Commission makes similar observations in respect of the second part of the RTI petition, sought for by the petitioner vide his RTI application dated 5-7-2013.

Due to his absence at the time of hearing today, this Commission do not see any further cause of action on the RTI application dated 5-7-2013 and the complaint petition dated 16-12-2013

With the above order the complaint petition dated 16-12-2013 is disposed of.
