Both parties are absent. No written statement received.

However, in view of the large number of cases pending before this Commission, the Second Appeal petition dated 06.01.2015 is taken up for consideration on merit, based on record.

On perusal of case record, it appears that Md. Abul Hussain Barbhuiya had filed an RTI application on 10.10.2014 before the CDPO, Hailakandi ICDS seeking for information on i) Anganwadi centers; ii) information on number of workers and helpers as well as name and address; iii) grant received from Government by the Anganwadi centers. On 01.12.2014, he filed the First Appeal before the District Social Welfare Officer, Hailakandi due to non receipt of information from the CDPO, Hailakandi.

The Second Appeal was filed before the Commission on 06.01.2015 on the ground of non receipt of information from the CDPO, Hailakandi and the First Appellate Authority. Reminder was given to the Commission by the petitioner on 11.02.2015 and 20.05.2015. Accordingly, notice was issued to the petitioner and the SPIO to appear for hearing on 22.04.2016.

In view of the absence of both the parties, it could not be ascertained whether the information sought for had been furnished to the petitioner after issue of the hearing notice. The Commission, therefore, directs the SPIO to furnish the information as sought for by the petitioner, within 15 days of receipt of this order.

With this above direction, the Second Appeal petition is hereby disposed of.
