Appellant absent. However, a Written Statement dated 24.04.2016 has been received from him by email which is taken on record.

Dr. Bibhupada Nath, SPIO/SDM & HO, School Health, Cachar, office of the JDHS, Cachar is present. A W/S dated 22.04.2016 has also been received from the SPIO which is taken on record.

Perused the W/S from the Appellant. He has submitted that he has not received the information he had sought for through his Application dated 23.08.2012. He has however added that he has received the salary for the period pertaining which he had sought information. He has also sent an apology for his absence from today's hearing on account of pre-occupation with official work.

Perused the W/S submitted by the SPIO. It has been submitted that case of the RTI Application dated 23.08.2012 by the Appellant could not be traced. However, it has been submitted that information on a similar RTI Petition received earlier had been provided and another communication has been written to the Appellant through a letter dated 22.04.2016 in response to the RTI Application under consideration.

Heard the SPIO. He reiterated the context of the W/S.

Considering that the Appellant has admitted that he has received the salary relating to which he had sought information and that the SPIO has now furnished a reply to his RTI Application, the Commission decides to dispose of and close the Appeal case.
