Sri Abhijit Gupta, Head Teacher, No. 1068 Kukichara L.P. School is present with a Written Statement dated 25.04.2016 which is taken on case record.

A Written Statement 22.04.2016 has been received from the BEEO, Salchapra.

Appellant absent. However, a Written Statement dated 12.04.2016 has been received from him through which he has stated that he has not received the information he had sought for through his RTI Application dated 01.06.2012.

Perused the W/S from the Head Teacher. It appears that the Appellant had filed 2 (two) Applications on two different dates for the same information. It has been submitted that in compliance with the Commission's order dated 27.04.2015 in connection with the Complaint lodged with the Commission dated 18.12.2013 with regard to the RTI Application of 25.05.2012, the Head Teacher of the concerned school furnished the information to the Complainant. Evidence of dispatch of the information to the Petitioner has been enclosed with the W/S.

Perused the case record. It is seen that the RTI Application dated 25.05.2012 in respect of which the Complaint was disposed of with an order by the Commission as mentioned above, and the Application dated 01.06.2012 in regard to which today's hearing has been taken, sought the same information. The matter has been treated as two different cases owing to two separate Applications having been made and followed up by a Complaint in respect of one and Second Appeal in respect of the other.

In view of the facts brought out above and particularly the fact that the information sought for by the Appellant/Complaint has been provided to him by the Public Authorities in compliance with the orders of the Commission dated 27.04.2015, Second Appeal Petition dated 15.12.2012 is disposed of.

On the same grounds, and the as the Commission's order has been complied with, the Complaint case no. SIC/CCR.1/2014 is disposed of.
