ORDER 29.04.2016

The SPIO and the Appellant absent without information.

The First Appellate Authority/Assistant Executive Engineer (PHE), Silchar Division No. II, Silchar has not apprised the Commission about the steps he may have taken to dispose of the First Appeal dated 26.11.2013 in time.

Considering that a significant number of cases are pending for hearing, it is decided to go ahead with the hearing *ex-parte*.

Perused the case record. It is seen that the Appellant had filed the Second Appeal with the Commission dated 24.02.2014 not being satisfied with the information provided to him by the SPIO. It is also seen that the documents relating to the information sought for by the Appellant would be substantial in volume.

In the absence of the parties, it could not be ascertained as to whether further information has been provided to the Appellant/Applicant subsequent to filing of his Second Appeal

In view of the above, the Commission hereby orders that should the Appellant still be interested in receiving the remaining information/documents, he may visit the SPIO's office and inspect the relevant records within a period of 10 days of receipt of this order and complete the process within 2 days of the visit, and that SPIO shall extend all cooperation for this purpose. Should there be any cost of photocopying of documents etc., the SPIO shall provide upto 20 copies, free of cost and the Appellant shall bear cost for photocopying beyond that number.

With this, the Second Appeal Petition is disposed of.
