The petitioner, Md. Asraf Ali is absent without any intimation.

The Public Authority is represented by Md. Pashan Ali Sheikh, District Agricultural Officer & First Appellate Authority (FAA), Goalpara along with Md. Abdul Wahid Ahmed, SPIO and SDAO, Goalpara, office of the District Agricultural Officer, Goalpara.

The SPIO has submitted a written statement dated 26.04.2016 stating that he was not aware that the information was not furnished by the Agricultural Development Officer (ADO), Bardamal Circle, Goalpara. He had directed the ADO, Bardamal Circle, Goalpara vide his letter dated 10.06.2014 to furnish the information directly to the petitioner. He also mentioned that the Petitioner had not approached him for non-receipt of the information and was also not aware of the First Appeal filed before the DAO, Goalpara on 14.07.2014 which was enclosed with the hearing notice of the Commission dated 28.04.2016.

The FAA present stated that he had joined as DAO, Goalpara only on 30th December, 2015 and so was not aware of the First Appeal filed by the applicant. The Public Authority has however, sought for time to furnish the information to the petitioner, which is allowed.

The Commission hereby directs the SPIO to furnish the required information within one month from the date of receipt of this order.

With the above, direction the Second Appeal petition dated 22.08.2014 is disposed of.
