ORDER

The Public Authority is represented by Smt. Nirola Phangchopi, ACS, SPIO/Additional Deputy Commissioner, Nalbari along with a Written Statement dated 21.04.2016 which is taken on record.

The Appellant absent without any information.

Perused the aforementioned W/S and heard the SPIO. It has been submitted that the status of the RTI Application could not be ascertained after the Commission's hearing notice was received on 18.04.2016 in the afternoon. One month's time has been prayed for to submit a W/S to the Commission.

The Commission is of the view that the interest of the Petitioner/Applicant would be better served if the SPIO can provide the information sought for by him rather than fixing another hearing, if the information has not already been provided.

The Commission therefore, hereby orders that the SPIO shall ascertain the status of the RTI Application dated 16.10.2014 submitted by the Appellant and provide the information to him, free of cost, within 15 days of receipt of this order, if already not provided.

There is no evidence of the First Appellate Authority (FAA)/Deputy Commissioner, Nalbari having disposed of the First Appeal dated 05.12.2014. The Commission hereby orders that the FAA shall consider and dispose of the said First Appeal, with a Speaking order, within a period of 21 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.
