**O R D E R**

The petitioner Sri Dulal Bora is present. The public authority is represented by (1) Smti Jinti Das, ACS, Deputy Secretary & SPIO, Elementary Education Department (2) Smti Rumi Choudhury, Deputy Director and SPIO, Directorate of Elementary Education (3) Sri Khagen Deka, Sr. Administrative Assistant, Office of the Director of Elementary Education, Kahilipara, Guwahati-19 & (4) Sri Nitul Barman, Sr. Administrative Assistant, Assam Secretariat, Dispur.

The second appeal petition dated 27-12-2013 is taken up for consideration, on merit, in presence of both the parties.

From perusal of the case records, it is seen that the petitioner Sri Dulal Bora filed an RTI petition dated 22-7-2013 , seeking information on the withholding of salary of one teacher by the name of Sri Roheswar Bora under Golaghat North Block, Dergaon.

The SPIO of the Directorate of Elementary Education has submitted a copy of letter No. BEEO/GNB/RTI/2013 dated 9<sup>th</sup> September, 2013 from the BEEO, North Block, Dergaon addressed to the petitioner Sri Dulal Bora, furnishing the required information. However, the petitioner said that he has not received the information till date.

This Commission, therefore, directs the SPIO of the Directorate of Elementary Education to furnish a copy of the information already sent to the petitioner again today by taking an acknowledgement receipt from the petitioner.

By the second part of the RTI petition, the petitioner wanted to know the reasons why the same person namely Sri Sajat Baruah remains in the same place of posting , i.e., Dergaon irrespective of his position as SI or BEEO. This Commission is of the view that such questions do not fall within the purview of the definition under Section 2(f) of the RTI petition, 2005.

With the above order the second appeal petition dated 17-12-2013 is disposed of.
