**O R D E R**

The petitioner Sri Dulal Bora is present. The public authority is represented by the SPIO (1) Sri Isfaque Rahman of Gauhati Municipal Corporation (2) Sri Santanu Das, Associate Planner, GMC (3) Sri Nabajyoti Bordoloi, Zonal Engineer, GMC and (4) Smti Archana Konwar, Zonal Engineer, GMC

The second appeal petition dated 20-5-2013 is taken up for hearing in presence of both the parties.

From perusal of the case records, it is seen that the petitioner Sri Dulal Bora filed an RTI petition dated 28-2-2013 before the Commissioner, Guwahati Municipal Corporation seeking the following information :-

- (a) Population under GMC area . What kind of development had been done by GMC during the last 2 (two) financial years together with detailed reports and utilization certificates.**
- (b) No. of people occupying Govt. lands under the jurisdiction like Hills, Water Bodies etc. How they occupied Govt .lands without getting GMC permission. If the same is illegal then what kind of action are you taking against them.- Details to be given.**

It is seen that vide letter dated 25-4-2013, the Collector and PIO of GMC informed the petitioner Sri Dulal Bora the population of Guwahati as of 2011 census.

The list of development schemes submitted by Water Works branch of GMC was also enclosed. The petitioner was also requested to be more specific in seeking information, so that it can be provided properly.

As regards encroachment, the petitioner was advised to seek the information from the office of the Deputy Commissioner, Kamrup (Metro)

Thereafter, the petitioner filed his first appeal petition before the Commissioner, GMC on 20-4-2013. The Commissioner in his capacity as the First Appellate Authority heard and passed an order on the first appeal petition on 20-5-2013. The petitioner Sri Dulal Bora was present at the time of hearing of the first appeal petition and it was explained to him that GMC has given the sought for information pertaining to it.

The First Appellate Authority disposed of the first appeal petition dated 20-5-2013. The petitioner's second appeal petition was 20-5-2013 i.e, the same date as the date of the order of the first appeal petition.

It, therefore, appears to be infructuous. Hence the second appeal petition is disposed of.
