O R D E R

The public authority and the petitioner both are absent without any information. In view of the large number of cases pending before this Commission the second appeal petition dated 30-11-2013 is taken up for consideration, on merit, in the absence of both the parties.

Vide his RTI petition dated 16-8-2013 the petitioner wanted the following information:

- (a) Number of candidates who had applied for Anganwadi workers and Helpers , interview for which was concluded on 13-8-2013. The petitioner also wanted photo copies of all the applications.**
- (b) How many of those applications were found to be eligible and how many in-eligible.**
- (c) On what grounds the in-eligible applications were considered to be ineligible.**

This Commission is of the opinion that giving photo copies of the applications submitted by the candidates are Third Party information for which the public authority will have to follow the procedure laid down in Section 11 of the RTI Act, 2005.

This Commission, therefore, directs the petitioner to inform the public authority within 15 days from the date of receipt of this order, whether he is still interested in getting photo copies of the applications. On receipt of affirmative communication from the petitioner the public authority will take further action under Section 11 of the RTI Act, 2005.

As for the remaining information, this Commission directs the CDPO, Urban ICDS Project, Beltola , Guwahati- 28 to allow the petitioner , if he is still interested to get the information, to inspect relevant records and documents during office hours within 15 days from the date of receipt of this order, and also to allow him to take notes and photo copies of the relevant records and documents free of cost up to 25 copies and on payment of Rs. 2/- for every additional page of photo copy, thereafter.

The petitioner is also directed to give inform the public authority at least 2 days prior notice before his proposed date of inspection of records.

With the above order the second appeal petition dated 30-11-2013 is disposed of.
