Both the parties are absent without intimation.

However, in view of the large number of cases pending before this Commission, the Appeal petition dated 26.11.2014 is taken up for consideration on merit, based on record.

On perusal of the case record, it appears that the petitioner Md. Anowar Hussain had submitted an RTI application before the Project Director, DRDA, Goalpara on 31.05.2014 seeking for information on IAY houses from 2009-10 to 2013-14. The RTI petition was transferred to the BDO, Kharmuja Development Block on 05.06.2014 for furnishing the information within the stipulated time. The petitioner submitted his First Appeal dated 16.07.2014 to PD, DRDA Goalpara as no information was furnished to him. The SPIO, DRDA, Goalpara referred the matter to BDO, Kharmuja Development Block to furnish the required information vide his letter dated 05.08.2014. The petitioner filed his Second Appeal dated 26.11.2014 before the Commission as he was not furnished any information by PD DRDA, Goalpara.

The Commission directed the SPIO, office of the BDO, Kharmuja Development Block, Goalpara to furnish the information before the date of hearing on 26.04.2016 so that the matter may be closed.

In the absence of both the parties, it could not be ascertained whether the SPIO had furnished the information to the petitioner on receipt of the hearing notice.

In view of the facts stated above the SPIO, office of the to BDO, Kharmuja Development Block is directed to furnish the information as sought for by the appellant within 10 days of receipt of this order, if not already furnished.

With this above direction, the Second Appeal petition is disposed of.
