Seen the written statement submitted by Sri Dhaneswar Roy, Block Elementary Education Officer, Lakhipur, Goalpara enclosing a copy of the letter dated 01.07.2014 from the Headmaster, Nutan Holdibari, M.E. Madrassa wherein he had instructed the applicant to deposit a sum of Rs. 600/- as expenditure for making photocopy of his RTI documents within a period 7 days from the issue of his letter dated 01.07.2014 and receive the documents from his office. Seen also the written statement dated 25.04.2016 submitted by Md. Surat Zaman, Headmaster, Nutan Holdibari, M.E. Madrassa.
