The DEEO cum DMC, SSA, Sonitpur has submitted a written statement dated 03.05.2016 intimating that he had submitted the information to the petitioner Sri Dilip Nath enclosing a copy of the information addressed to the petitioner. In view of the absence of the petitioner, it could not be ascertained whether the petitioner is satisfied with the information furnished by the DEEO cum DMC, Sonitpur.

The Commission therefore directs that in case the petitioner is not satisfied with the information furnished, he may approach the SPIO within 15 days from the date of receipt of this order and the Public Authority concerned shall furnish the information, if sought for by the petitioner, within 30 days from the date of receipt of such intimation or make available the documents for inspection during office hours within two working days and allow the petitioner to take notes and photocopies of the documents sought for, free of cost up to 50 copies and thereafter, on payment of Rs. 2/- on every additional pages.

The Petitioner will inform the SPIO two days in advance in writing, the date on which he desires to inspect the documents.

With the above direction, the complaint petition is disposed of.
