**O R D E R**  
10.05.2016

The SPIO is absent. By sending an email dated 09.05.2016 he submitted that he could not attend hearing on account of "serious illness". A Written Statement dated 29.04.2016 has also been received from him separately which is taken on the case record.

Sri S. A. Laskar, First Appellate Authority (FAA)/Joint Director, office of the P& RD Department, Assam is present along with his assistant. He has submitted a W/S dated 10.05.2016 which is taken on the case record.

The Appellant present.

Perused the aforementioned W/S from the SPIO. It has been submitted that according to the records of his office there was no RTI Application from Sri Nikhil Das, the Appellant, pending in his office. Further, the first hearing notice from the Commission dated 08.04.2016 has not been received by him therefore he was not in a position to submit a reply on the contents of the RTI Application.

Perused the W/S from the FAA. It has been submitted that the First Appeal dated 15.11.2013 which was filed in his office could not be traced.

Heard the Appellant. He submitted that he has not received any further information subsequent to filing of his Second Appeal dated 06.01.2014. In response to the submission made by the SPIO through his W/S, the Appellant stated that there is a seal on a copy of the RTI Application he has. He further submitted that the SPIO has not responded to his Application although there is direction from the D.C.'s office to him for providing the information.

Perused the case record. It is seen that the copy of the RTI Application which is in record of the Commission contains a photocopy of the postal receipt dispatched by registered post.

In view of the facts brought out above, the Commission hereby orders as follow –

1. The SPIO, office of C.E.O., Cachar Zilla Parishad shall furnish the information as sought for by the Applicant/Appellant, free of cost, within a period of 10 days of receipt of this order;
2. The SPIO, office of C.E.O., Cachar Zilla Parishad shall submit a written explanation to the Commission as to on what basis he had categorically stated that no such Application from the Appellant was pending in his office;
3. The First Appellate Authority/Joint Director, P & RD Department, Assam shall consider and dispose of the First Appeal dated 15.11.2013, with a speaking order, within a period of 21 days of receipt of this order.
