Sri S.K. Panigrahi, Principal *i/c*, assisted by Md. Mohibul Hoque Choudhury, SPIO, Sapatgram College, Dhubri present. A Written Statement dated 11.05.2016 received from the Principal which is taken on the case record.

The Appellant present. She has submitted a letter dated 12.05.2016 stating that she was still interested in the information and has prayed for the Complaint to be treated as Second Appeal.

Perused the case record. It is seen that the Applicant had submitted her Complaint on not receiving the complete information sought for from the SPIO.

Perused the aforementioned W/S from the Principal. It has been submitted that it has taken time to provide the information owing to the time taken in corresponding with the Applicant with regard to payment of cost of photocopying, and that part of the information had been supplied based on the amount received. It has further been submitted that some more cost of photocopying had been sought from the Applicant, deposit of which was awaited. It has been added that the College has uploaded in its website information relating to the College as contained in Self Study Report and that the College is trying to its best to be transparent in providing information. In his deposition the Principal has reiterated this position.

The Appellant and her assistant stated that some of the information/documents received by them which were not duly certified and authenticated, some of them did not contain the seal/stamp of the authorities concerned. It has also been submitted that they would like this documents to be duly certified and that copies provided.

In view of the facts brought above, the Commission hereby orders that the Appellant shall specify in writing the part of the information still due and the defect in those that he had received, within a period of 10 days of receipt of this order. On receipt of the same the SPIO shall keep the records ready for inspection. The SPIO shall provide photocopies of documents upto 20 copies free of cost and the rest of the copies would be paid for by the Appellant at the prescribed rate. The entire exercise would be completed within 2 days.

With this, the Second Appeal petition is disposed of.
