Md. Sahidul Islam Saikia, E.O.(C)/SPIO, Jamadarhat Development Block is present. A Written Statement dated 11.05.2016 received from the First Appellate Authority/P.D., DRDA, Dhubri which is taken on the case record.

The Appellant absent without any information.

The Appellant had filed the Second Appeal Petition with the Commission on not being satisfied with the information/documents received by him from the SPIO on the ground that the same had not been provided to him point wise with reference to his RTI Application and there was no forwarding letter.

Perused the aforementioned W/S from the FAA. It has been submitted that as the Appellant did not attend the hearing in connection with his First Appeal, nor had he pursued the case it was assumed that he was no longer interested in the information.

Heard the SPIO. It has been submitted that he was not fully apprised of the shortcomings in the information already provided.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall provide the information/documents once again with a forwarding letter and arranging them in accordance with the RTI Application, within a period of 10 days of receipt of this order.

With this, Second Appeal Petition is disposed of.
