The Public Authority is represented by Ms. Arifa Begum, CDPO, South Salmara. A Written Statement dated 16.05.2016 received from the her which is taken on the case record.

The Appellant present along with an assistant.

Perused the aforementioned W/S. It has been submitted that owing to paucity of time after receipt of Commission's notice a detailed submission could not be made regarding the status of furnishing information in response to the RTI Application. Some time has been prayed for, for this purpose. Depositing before the Commission, the SPIO reiterated the position made in her W/S.

Heard the Appellant and his assistant. It has been submitted that the Appellant had received part of the information that he had sought for, and that he was not satisfied at the incomplete information.

Perused the case record. It is seen that in his Appeal the Appellant had not specified the information he had received and that which was awaited.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall write, within 7 days of receipt of this order, to the SPIO specifying the information yet due to be received in connection with the RTI Application dated 28.10.2013, and on receipt thereof the SPIO shall make available records/documents for inspection, provide copies free of cost up to 25 pages and on payment beyond that. The entire exercise will be completed within 2 days.

With this, the Second Appeal case is disposed of.
