ORDER 09.05.2016

Both the SPIO/Head Teacher, No. 1365 Rangha Khalerpar L.P. School and the First Appellate Authority/D.E.E.O., Cachar absent. However, Written Statement dated 07.05.2016 has been received from the SPIO /Head Teacher of the school which is taken on the case record.

There is no evidence of FAA/DEEO, Cacher having disposed of the First Appeal dated 16.10.2014 as required by the RTI Act, 2005.

The Appellant is absent. However, an apology for his inability to attend today's hearing received from him and taken on record.

The Appellant has submitted that he has not received the information he had sought for.

Perused the aforementioned W/S from the SPIO/Head Teacher. It has been submitted that he was unable to attend today's hearing as he was proceeding for medical treatment of his wife to South India and has assured to provide the information to the Applicant/Appellant within 2 (two) weeks.

In view of the facts brought out above, the Commission hereby orders as follows –

- 1. The SPIO/Head Teacher, No. 1365 Rangha Khalerpar L.P. School shall furnish the information as sought for by the Applicant/Appellant, free of cost, within a period of 21 days of receipt of this order;
- 2. The First Appellate Authority/D.E.E.O., Cachar shall consider and dispose of the First Appeal dated 16.10.2014, with a speaking order, within a period of 30 days of receipt of this order.

With this, the Complaint case is disposed of.
