# <u>ORDER</u>

The petitioner Sri Subal Ch. Ray and the public authority to be represented by the BDO, Manikpur Development Block both are absent without any information.

The second appeal petition dated 24-12-2013 with reference to the petitioner's RTI petition dated 25-6-2013 is taken up for consideration ex-parte.

From perusal of the case records it is seen that by his RTI petition dated 25-6-2013 the petitioner wanted information on *"construction of TFC fund of BTC area under Manikpur Development Block after 2005-2006 to 2012-2013"* 

This Commission notes that what specific information the petitioner wants is not clear from his RTI petition. Perhaps he wants to know :-

- (a) Names of construction works, if any , executed in BTC area under Manikpur Development Block with the 12<sup>th</sup> and 13<sup>th</sup> Finance Commission Grants (whose Award period were 1<sup>st</sup> April, 2009 to 31<sup>st</sup> March, 2010 and 1<sup>st</sup> April, 2010 to 31<sup>st</sup> March, 2015 respectively)
- (b) Cost of constructions
- (c) Status of construction with utilization / completion certificates.

If the information has not been furnished then, this Commision directs the BDO, Manikpur Development Block, District- Bongaigaon, Assam to allow the petitioner to inspect the relevant office records and documents, during office hours on any working day, within 15 days from the date of receipt of this order, and also allow him to take photo copies, free of cost up to 20 pages and thereafter @ Rs. 2/- for every additional page of photo copy.

With the above order the second appeal petition 24-12-2013 is disposed of .
