## ORDER

The petitioner Sri Dhansing Ronghang as well as the public authority to be represented by the SPIO of the office of Sub-Divisional Agricultural Officer, Hamren, Diphu, Karbi Anglong Autonomous Council, both are absent without any information, although this Commission's Notice dated 12<sup>th</sup> April, 2016 was sent to both of them.

The second appeal petition dated 20-11-2013 is taken up for consideration exparte in the absence of both the parties.

From perusal of the case records, it is seen, that the Sub Divisional Agricultural Officer, Hamren, Karbi Anglong furnished some information to the petitioner vide letter dated 3-9-2013, in response to the RTI petition dated 3-6-2013. The petitioner's first appeal was dated 29-7-2013, followed by second appeal petition dated 20-11-2013.

The second appeal petition was filed on the ground of furnishing incomplete and unsatisfactory information by the public authority to the petitioner. But the petitioner did not specify which part of the information received by him was incomplete and unsatisfactory. In his absence it could not be ascertained by the Commission.

Against the above facts and circumstances of the case, the SDAO, Hamren, Karbi Anglong is directed to allow the petitioner to inspect the relevant office records and documents, if he wants to do so, during office hours on any working day within 30 days from the date of receipt of this order and allow him to take notes and photo copies of documents, free of cost up to 25 copies and thereafter, on payment of Rs. 2/- for every additional page of photo copy, so as to furnishing of complete information to the petitioner.

With the above order the second appeal petition dated 20-11-2013 is disposed of.
