O R D E R

The petitioner Sri Dulal Bora is absent. The public authority is represented by (1) Sri Babul Mudoj, PIO and Addl. Executive Officer, Assam Khadi and Village Industries Board, Chandmari, Guwahati-3 and Sri Pabitra Kr. Deka, U. D. Asstt of the same office.

The second appeal petition dated 26-10-2013 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records it is seen that the petitioner Sri Dulal Bora vide his RTI petition dated 22-7-2013 filed before the Chief Executive Officer, Khadi & Village Industries Board, Assam, seeking information on various aspects of CMEGP scheme from its inception till 20-7-2013. The public authority i.e., the Additional Executive Officer and PIO of Khadi and Village Industries Board, Assam has submitted a written statement dated 29-4-2016 stating that they had already furnished the required information to the petitioner on 20-9-2013. As the required information had to be collected from various field offices and compiled, there was delay in furnishing the information.

This Commission accepted the PIO's prayer for condonation of delay.

By the same letter dated 20-9-2013 the PIO requested the petitioner to deposit Rs. 13,098/- for providing him photo copy of the list of beneficiaries. The petitioner has not deposited the amount till date for which the public authority also has not furnished the list of beneficiaries

In view of the above, this Commission directs the PIO of Khadi & Village Industries Board, Assam to furnish the list of beneficiaries to the petitioner, provided he deposits the required cost within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 26-10-2013 is disposed of.
