The petitioner Sri Mohan Bora is absent without any information.

The Public Authority is represented by Dr. Bhupen Talukdar, SPIO and Joint Director, Secondary Education, Assam.

In view of the large number of cases pending before this Commission, the Complaint petition dated 16.09.2015 is taken up for consideration *ex parte*.

The SPIO in his written statement dated 03.05.2016 stated that the petition of Sri Mohan Bora had been transferred to the Inspector of Schools, JDC, Jorhat to provide the information. The Inspector of Schools, Jorhat had submitted a report regarding provincialisation of post of Science Teacher in Bekajan Girls' High School with enclosures vide letter no. IS/JDC/NOM.Govt./Particulars/prov./2013/961 dated 23.03.2015. The SPIO has informed that on receipt of the same, the Director, Secondary Education issued an order dated 23.03.2015 based on order of the Hon'ble High Court in W.P. (C) no. 6843/2014 filed by Sri Mohan Bora, a copy of which was sent to the petitioners Sri Mohan Bora and Sri Pranabjyoti Saikia. The SPIO has stated that he could furnish the information to the petitioner, if the same was allowed by the Commission. He also stated that he is not aware whether the court case filed by Sri Mohan Bora was finally disposed by the Hon'ble High Court or was still pending in the High court for disposal.

Since, the Commission could not be apprised by the SPIO whether the matter is subjudice in the Gauhati High Court, the Commission directs the SPIO to ascertain the status of the case in the Hon'ble High Court and take action accordingly as per order of the Hon'ble High court.

With the above direction, the Complaint case dated 16.09.2015 is disposed of.
