The petitioner Sri Dilip Nath is present.

The Public Authority is represented by Sri Pranab Jyoti Goswami, DCP (Traffic), Sri Golak Ch. Deka, DSP, Assam Police, HQ, Ulubari.

The DCP (Traffic) informed that he had received the hearing notice of the Commission on 12.05.2016 and as such he could not submit written statement. He also stated that the information sought for relating to point no. 3 to 7 was almost ready. A few days time would however be required to furnish the complete information.

The Commission observes that the information sought for by the petitioner vide his RTI application dated 18.03.2014 involves a huge volume of information relating to several category of information for several years.

In view of the above, the Commission directs the petitioner to inspect the documents in the office of the DCP (Traffic) within 10 days from the date of receipt of this order and complete the inspection of documents during office hours within 2 working days. He will intimate the SPIO two days in advance, the date on which he wants to inspect the documents. The DCP (Traffic) is also directed to allow the petitioner to inspect the relevant documents as above and allow him to take notes and make photocopies of the sought for documents, free of cost, up to 100 copies and thereafter, on payment of Rs. 2/- for every additional page of photocopy. The entire process should be completed within 15 days.

The petitioner stated that he would be satisfied if the information is furnished to him and he would not have any further complaint.

As such with the above direction, the Complaint petition dated 12.08.2014 is disposed of.
