## ORDER 17.05.2016

The petitioner Sri Dibyojyoti Hazarika is present. He has stated that seven cases had been fixed for hearing today which are absolutely similar and all the seven Public Authority has come for the hearing. As such, all the seven cases are taken up for hearing together.

The Public Authority is represented by i) Sri Dhajen Basumatary, Member Secretary, Naharbari L.P School; ii) Sri Ratul Ranjan Saikia, Ex-Member Secretary, Laltapu Habidoloni L.P School; iii) Rajendra Kalita, Ex-Member Secretary, Dekorai TE No.5 L.P School; iv) Sri Amar Barnat, Ex-Member Secretary, Katarkati Mirihola L.P School; v) Sri Ram Hazarika, Ex-Member Seretary Pachim Katarati L.P School; vi) Md. Sofiuddin Ahmed, Member Secretary, Bhojmari Bhari Chuburi L.P School; vii) Sri Satrughan Nag, Ex-Member Secretary, Adabhati L.P School.

The petitioner Sri Dibyajyoti Hazarika filed the RTI applications dated 16.05.2014 seeking information from the DEEO, Sonitpur in connection with construction of 59 numbers of new L.P Schools which were upgraded from EGS centre.

The DEEO, Sonitpur vide letter dated 26.05.2014 transferred all the 59 RTI applications to the DMC, SSA, Sonitpur with a direction to submit a detailed information to the petitioner directly.

The petitioner filed his First Appeal petition before the SPIO, office of the DEEO, Sonitpur on 05.07.2014 as he was not provided with the information within the time limit. On 17.07.2014, the DMC, SSA, Sonitpur furnished the information to the petitioner on 46 numbers of RTI applications with detailed data against 59 numbers of RTI applications with a copy to Mission Director, SSA, Sonitpur as well as SPIO, office of the DEEO, Sonitpur and others. The DMC, SSA, Sonitpur also transferred the RTI applications to the BEEO, BMC, Naduar Educational Block with a direction to submit a reply by him within 3 days i.e. 19.07.2014 without fail.

The petitioner on 24.07.2014 has sent a reply to the SPIO, office of the DEEO, Sonitpur rejecting the data furnished by the concerned authorities on 9 grounds. On 08.09.2014, the petitioner issued a reminder to the First Appellate Authority (FAA)/DEEO/DMC, Sonitpur that till date no order had been passed in connection with the 59 numbers of RTI Applications by the FAA and requested the FAA to pass appropriate order under section 19 and 20 (1) of the RTI Act, 2005 otherwise the petitioner would be compelled to approach the Information Commission.

The petitioner on 13.10.2014 filed the Second Appeal petition. In his appeal petition, he stated that the required information was not furnished to him nor any order given by the FAA, except a verbal assurance that the process was on without any justification. He also stated that he visited the office several times to know the status of the First Appeal petition and ultimately reminded the FAA on 08.09.2014 to pass appropriate order under section 19 and 20 (1) of the RTI Act, 2005 but no reply was received by him and hence the Second Appeal. He has stated that the Second Appeal was not filed within the time limit of 90 days from the date of filing of the First Appeal and that 9 days delay occurred due to false assurance of the FAA and hence should be condoned. He also claimed Rs 250/- per day as penalty for non-furnishing of information.

On careful perusal of the relevant documents available, it appears that after filing of the First Appeal on 05.07.2014, the DMC, SSA on 17.07.2014 (i.e. 12 days from the filing of the

First Appeal Petition) had furnished the information to the petitioner on 46 numbers of RTI applications. It also appears that the DMC, SSA on the same date i.e. 17.07.2014 had transferred the RTI applications to the BEEO for furnishing information to the petitioner within 3 days. No record is available on the action taken by the BEEO nor any record is available on the information furnished to the petitioner. The petitioner also stated that the information sent to him was not available with him and he was not aware of information received on which 46 schools.

The petitioner on 24.07.2014 filed a Rejection petition before the SPIO, DEEO, Sonitpur that he had rejected the data furnished by the DEEO on 9 grounds. On perusal of the grounds of rejection such as submission of data is not as required, detail cost of labours and materials, percentage of progress and remark portion of the progress report is silent and no reasonable cause for non-completion of schools etc. are general in nature. It is not specific as to what data has not been furnished. Hence, the grounds of rejection cannot be accepted.

During the hearing, the petitioner stated that he is now satisfied with the developments of all the L.P schools and to that effect he has given a written statement that he is no longer interested in getting the information as sought for earlier on the 59 RTI applications, except for one i.e. Narayanpur L.P. School.

In view of the facts and circumstances stated above and the written statement submitted by the petitioner today, the Second Appeal petition dated 13.10.2014 is disposed of and the Commission directs the petitioner to file a separate petition on Narayanpur, L.P School, if he so desires.

As the petitioner stated that all the RTI applications are same and is of same nature seeking similar information, this order will be applicable to all the 59 cases. A copy of the order be kept in all the 59 related files.
