**O R D E R**

The petitioner Shri Dulal Bora is absent without any information. The Public Authority is represented by (1) Md. Ikramul Hussain, ACS, SPIO of Personnel (A) Department, Govt. of Assam, and (2) Shri N. Basanta, Jr. Administrative Assistant, Personnel (A) Department. In view of the large number of cases pending before this Commission the Second Appeal petition dtd 19.11.13 filed by the applicant Shri Dulal Bora with reference to his RTI petition dtd 2.8.13 is taken up for consideration on merit and ex-parte in absence of the applicant/appellant.

The Secretary and First Appellate Authority of Personnel (A) Department has sent a written statement dtd 19.4.16 stating that in reply to the RTI petition dtd 2.8.13 of the petitioner, Shri Dulal Bora, required information was furnished vide Personnel Department's letter No. AAP.103/2013/12 dtd 26.9.13. The First Appellate Authority has also enclosed copies of information already furnished to the petitioner. It appears that the information already furnished meets the requirement of the RTI petition dtd. 2.8.13.

In his First Appeal petition dtd 19.9.13 the appellant's only ground was that till then he had not received the sought for information. The First Appellate Authority has further mentioned in his written statement that several dates were fixed for hearing of the first appeal petition but the appellant was absent on every occasion.

In view of the above facts and circumstances of the case, the Second Appeal petition dtd 19.11.13 is found to be without any merit and hence dismissed.
